It is worth noting that the global North and its greatest skeptic on economic and social rights, the United States have championed this effort, supplementing it heavily through the U. Partnerships of states, intergovernmental organizations, nongovernmental organizations, and the private sector have begun to address the subjects of these two protocols in particular.

According to some local NGOs, several hundred women are trafficked into the country. These included domestic charges of racism and anti-immigrant discrimination, law enforcement abuse, mass surveillance, media suppression and "restrictions on rights and freedoms under the pretext of fighting terrorism," as well as "violations of human rights committed by the United States in other countries - in the framework of the so-called anti-terrorist operations. A combined UN and African Union peacekeeping force was also established to help mitigate the violence. It addresses acute protection needs of children in humanitarian crisis zones, as well as more general health, education, and other basic needs.

To hold perpetrators accountable, the Rome Statute established the ICC. Under emergency regulations, authorities may open and destroy mail based on security considerations.
